Thus, all the HoSs of Government Schools under DoE are hereby directed to designate a teacher- coordinator (preferably a PGT) to facilitate the interested students of classes 5 to 12 to take part in the 12th International Humanity Olympiad, Spiritual Eloquence – National Open Oratory Contest & Spiritual Echoes – National Open Poetry Recitation Contest through website www.dhyankaksh.org

The Competent Authority has granted permission for the period of **06th April 2026 to 06th August 2026** with the following terms & conditions:

1. **No data of the students/parents address, contact numbers & findings of the project will be shared in the light of the privacy concern of the parents and students.**
2. The schools working should not be disturbed and safety & security of the students should be ensured.
3. No advertisement, i.e., name, sign, logo, sponsorship etc. should be displayed nor distributed by anyone.
4. **The Head of School (HoS) must be satisfied with the quality of the infrastructure provided by the NGO/Organization keeping in mind the safety and security of the students.**
5. **The HoS to ensure that the project is run under the strict supervision of the designated teachers.**
6. The recognition of the NGO/ Organization should be registered & validated by the Competent Authority. Further it is the responsibility of the Head of the School (HoS) who should be satisfied & convinced by the NGO/ Organization before the commencement of the subject.
7. There shall be no uploading of the images/pictures/videos of the students on media including social media except with the prior written permission of the Director (Education)
8. Privacy of students/parents should not be affected in the process of project
9. The finding of the project should be shared with the Directorate of Education & not to be published in any media (Print/Electronic/Social)
10. The NGO/ Organization has to ensure that no damages occur while conducting the programme. It will be the sole responsibility of the Organization & it should be rectified the entire satisfaction of the HoS, if there is any damage.
11. The permission is purely provisional & liable to be withdrawn at any time, if it is found to be against the national interest or causes any type of obstruction in the functioning of DoE as well as violation of these terms & conditions.
12. List of project team & their Bio-Data will be shared with the HoS prior to project.
13. The DoE will be indemnified against any legal/financial liability/litigation that may arise out of the project process or its findings.
14. No data of the students/parents address, contact numbers & findings of the project will be shared in the light of the privacy concern of the parents & students.
15. **The completion report of the project should be submitted to DDE (NGO) branch**
